### Effects and Risk Assessment

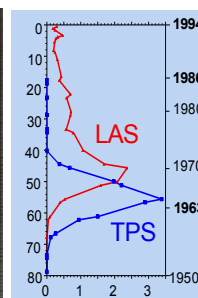
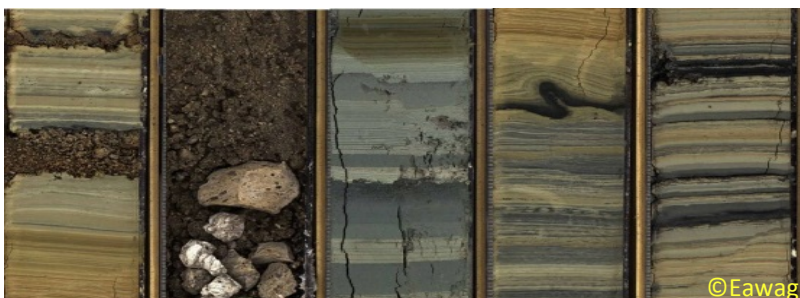
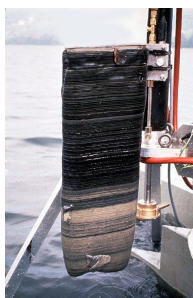
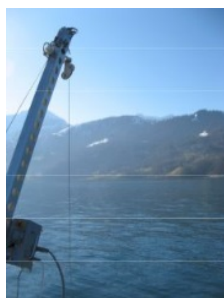
